For want of the 406th material could not be made sure up to now whether the device does not have the 406th high-level armament. From the cassettes from the scope of supply it is likely.

Rondo 308 = 308 mm

Rondo 406 = 406 mm

I suppose which became our rondo of from 308 to 406 hochgerüstet, but the cassettes make no sense.

The rondo 406 is ideal for Heidelberg GTO 52 format if he has a punch. We must still check this.

Stadard resolution: 500 and 100 l / cm (in 1270 and 2540 dpi)

Optionally: 750 and 1500 l / cm (in 1905 and 3810 dpi) we must still examine whether our rondo has this
