Digital telephoto lens of the Di-II generation. The objective was conceived exclusively for digital reflecting reflex cameras with sensors to 16x24mm and delivers a high image quality with regard to resolution, contrast and sharpness. In addition to the standard objective of digital reflecting reflex cameras opens 55-200mm the important tele-area and can be used for portrait, nature, sport, theatre, and Peoplefotografie. The objective uses a new optical system to limit the angle of incidence of the beams of light to the picture sensor. This is necessary to do justice to the physical circumstances of the chip and to avoid a Randabdunklung. The occurring rays are limited about the whole focal length area to a narrow frame. Furthermore this was optimised 55-200mm with regard to resolution, scattered light and chromatic aberration, so that consistently high-quality pictures about all focal lengths can be made.
