The Fujitsu fi-5650C is a compact, high performance image scanner with automatic document feeder (ADF) for simplex and duplex scanning procedure, the space requirement is very low.

### Ergonomic and versatile

Through its daily volume of up to 8,000 sheets, it is particularly suitable in the production and use as a departmental scanner. Due to the speed of up to 60 pages / min. in color and 600 dpi is the fi-5650C highly suitable for scanning of graphics or photographs or other graphic areas where the resolution is sufficient. For increased ease of use for right-and left-handers this was the appropriate control panel on both the right and the left side of the scanner.

### Secure document handling

The new separation unit and the integrated ultrasonic sensor to support its fast, reliable paper handling, inclusive detect double and different paper textures. It takes its document feeder up to 200 sheets of paper in A3 to A8.

### Versatile Equipment

Among many features image enhancement options, the fi-5650C also has various processing functions for the optimization of the scan. These include the straightening slanted retracted templates (De-skew hardware) and the sensible pruning of the scan image to the actual format of the original (auto cropping). The simple connection of the fi-5650C to a PC via its dual Ultra SCSI / USB 2.0 interface.
