The Hewlett Packard DesignJet 2500CP is an inkjet printer with four cartridges in the colors cyan, magenta, yellow and black. With a resolution of 600 dpi for color and black and white it reaches the heavy coated paper used for a remarkable one Volltondrucker quality. The paper can be up to a width of 36 inches = 91.5 cm and a length of 25 m be printed.
