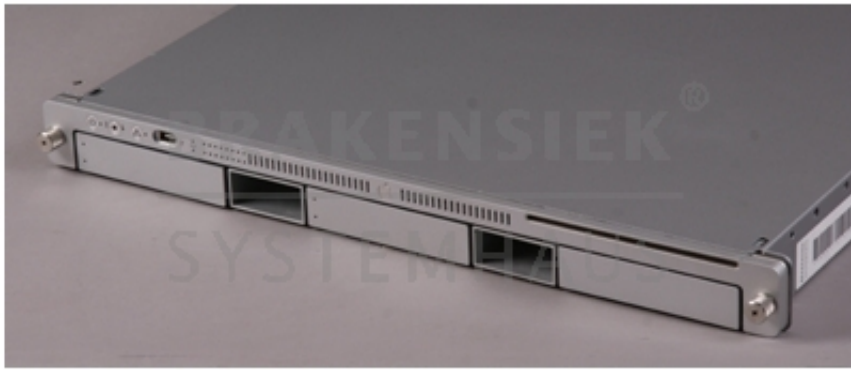

The Xserve supports up to three SATA and Sas disk drives and a maximum internal storage capacity from up to 2.25 TB. In addition, he orders more than two PCI express train slots with 8 Lanes and two Gigabit Ethernet connections which allow the simultaneous connection with several networks.
