#### Supervision and inspection to A4

The Agfa SelectScanPlus uses the Agfa Zoom technology, which allows the scanning of both supervisory and scanning of transparent originals improved quality with high productivity and versatility. The original holder for transparencies will be inserted in the Agfa SelectScanPlus. Consequently, it is protected from dust, vibration and interference of external light sources. Transparencies can be outside of the scanner mounted in the slide holder, while the scanner scans different templates. All plates are coded slide holder. Here, the Dynamic Focus feature that automatically slide holder positioned relative to the optical system exactly. It ensures proper focus throughout the image format and eliminates any variances. This special permit micro-step to fine tune brands in the micrometer range.

#### CCD scanning with 10,200 items

The flatbed color scanner with a linear CCD unit equipped with 10,200 elements, which captures all the detail in bright and dark areas and makes enlargements up to 2,000%. He reached up to 4,000 dpi scan resolution at a density range of 3.5 D (Dmax 3.7) and produced in accordance with scanning with high detail and high color saturation, even in dark colors, as they are known by professional films. The entire optical system is encapsulated, which reduces interference and dust to a minimum.
