In the SATA QuickPort Duo, two SATA hard drives are used: 2x 2.5" or 2x 3.5" or 1x 2.5" and 1x 3.5". The connection to the PC is made via either USB or two fast eSATA ports, with each hard drive assigned to an eSATA port, while they share the USB port (2 drives in the file manager will appear).

Rely on our hard drive tandem - the SATA QuickPort Duo.
